- **What are the guidelines regarding involvement? (Full rules and regulations download from 80829.com)**
 - a. Bring only high quality items which showcase your establishment's offerings. Remember, this is your time to make a positive, lasting impression to potential loyal customers.
 - b. Be set-up and ready to do business by 4:00 pm. (Senior citizens shopped early last year).
 - c. You are offered a 10 x 10 booth space. Tables and tents are your responsibility.
 - d. You must have a tent, no merchandise lying on the ground, professionally produced signs required.
 - e. You can drive your truck into the event site to off-load. Growers can work out of trucks - space permitting.
 - f. Freezers are permitted...electric is provided for no additional charge. (No 220w available).
 - g. Drop-in vendors must be registered by Monday at 8 am the week of the market with copies of all necessary permits and insurance in hand.
 - h. Health Department certificate (if required by law).
 - i. Absolutely no pets allowed.
 - j. No amplified noise from booths.
 - k. Submit your sales tax to the market manager each week.
